Provisional revised e-Admit Cards based on the prima facie information provided by the candidates in the application have been dispatched to all the eligible candidates who have completed their 2nd Step of online application at their registered emails address on **23<sup>rd</sup> May, 2015**. The candidature of the candidates appearing in the examination is "**Purely Provisional**" subject to scrutiny of their documents at the time of verification of document after conduct of written examination/at the time of interviews. **Those candidates whose name is in the list of eligible candidates and who have not received the revised e-Admit Cards by 25<sup>th</sup> May, 2015 may download their e-admit cards from CRWC website [www.crwcl.in](http://www.crwcl.in) from 26<sup>th</sup> May, 2015 onward.**
4. A "Facilitation Counter" shall also be functional at the above address to address the concerns of the candidates and facilitate other examination related issues. The "Facilitation Counter" shall be operational on **6<sup>th</sup> June, 2015 from 10.00 AM to 12.00 Noon at Ground Floor, Pragati Maidan Metro Station Building, New Delhi-110001**. No request for change in name, category, date of birth, etc shall be entertained since the candidates were advised to check their details in the online application before submission under any circumstances.
5. Candidates are advised to read the instructions printed on the revised e-Admit Card carefully/properly.
