3. The Specifications (mentioned in the NIT) listed are minimum requirement and any item of higher specification will be accepted.

4. The bidder should quote the price of items, their installation and comprehensive AMC keeping in mind of minimum requirement of 5 CCTV IP Bullet Cameras and their accessories for each terminal.

5. The proposed solution should be modular and scalable so that at later date the additional requirement can be met by add-on components based on rates quoted in price bid and shall be valid for contract period.

6. All components of the CCTV System should be compatible with one another

7. The proposed CCTV System's components must not be obsolete

8. The sizing of NVR should be commensurate with the number of cameras and number of days to record the video etc.

9. The specified items must be current/ recent in the Supplier's/OEM product line

10. All the items shall be branded and reputed

11. All CCTV Cameras and NVR should be of the same OEM.

12. Price quoted should be inclusive of all applicable taxes. In the event of introduction of any new tax, CRWC shall pay the new tax(if applicable) to the bidder as per the rate applicable at the time of payment.

13. Any change in the rate of tax (increase/decrease) quoted by the bidder would be to the account of CRWC and the payment will be made as per the rate applicable at the time of payment.

14. Further the bidder should clearly specify all types of taxes (including rate) separately in their bid.

15. The item procured during contract period post first installation & commissioning of CCTV system to be maintained by vendor. The AMC charges for such items shall be payable on pro-rata-basis, if applicable.

16. Vendor has to raise the bill showing the item cost, Installation cost and AMC cost separately.

17. It is price list of Unit Quantity of Itms. The total cost will be decided/computed after final installation depending upon the usage of quantity of items. (Please quote the price keeping in mind of Total CCTV System Installation Charges for four terminals)
