Whereas, Central Railside Warehouse Company Limited (CRWC), CPSE under Ministry of Consumer Affairs, Food and Public Distribution had invited e-tender no. - CRWC-II/RWC-FATUHA/H&T TENDER/2021-22/1453; dated 16.11.2021 for appointment of service provider for handling rail/road borne cargo at Railside Warehouse Complex Fatuha, Bihar.

Whereas, M/s. Maa Santoshi Goods Carring & Handling Agency hereinafter referred as “the Service Provider” have participated in the above-mentioned tender and furnished all requisite documents as per eligibility criteria.

Whereas as the Service Provider were selected as L1 bidder and accordingly the said contract was awarded to it vide letter no.- CRWC-II/RWC-FATUHA/H&T TENDER/2021-22/1980; dated 19.01.2022.

Whereas, thereafter the security deposit of Rs 4,50,000/- was also submitted by the Service Provider apart from execution of agreement and Custody & Indemnity bond dated 01.02.2022 and the Service Provider have taken over the work of H&T service provider at RWC Fatuha.

Whereas, vide letter dated 05.03.2022 the Service Provider had intended to withdraw from the said work/discontinue in providing the service at RWC Fatuha, Bihar and vide letter dated 29.03.2022 the Service Provider have conveyed its inability to continue the work of handling rail/road borne cargo at Railside Warehouse Complex Fatuha, Bihar beyond 30.04.2022.

Whereas, vide this office Notice dated 29.03.2022, it was also made explicitly clear that as per terms & conditions of the tender agreed by the Service Provider, that any default in the satisfactory performance or withdrawal from the work or non-completion of the work etc. shall make the Service Provider liable not only for forfeiture of security deposit but also to get the work done for the un-expired period of the contract, at the risk and cost of the Service Provider. In addition, the Service Provider are also liable to be suspension /banning for trade relation/blacklisting/debarring for participation in future Tender enquiry for the period upto 05 years.

Whereas, Service Provider's contract has been terminated vide letter no. - CRWCCO-CD/171/2021-COMM/362; dated 26.05.2022 and the work is awarded at the risk and cost of the Service Provider as per tender terms & conditions.

Whereas, vide this office Notice dated 13.06.2022 the Service Provider served upon the **Show Cause** as to why it should not be **backlisted and debarred by CRWC** for participation in future tender enquiries of CRWC for a period of 05 (five) years as it has breached the following terms and conditions of the tender:

- **BLACKLISTING/ DEBAR (Clause 19, page 29/76):**

The non-performing/defaulting service provider may be Suspended/banned for trade relation/black listed/debarred for participation in future Tender enquiry for the period upto 05 years based on the gravity of non-performance/breach of any terms of the Contract/default of the service provider by the Managing Director of the CRWC whose decision in the matter shall be final and binding.

Whereas, the Service Provider replied to the above said Show Cause Notice vide letter dated 27.06.2022 and same found to be unsatisfactory.

Whereas, the Service Provider have failed to perform at RWC Fatuha, Bihar, as per terms and condition agreed by it and breached the terms and conditions of the tender.
